JCHC BIMONTHLY MEETING Thursday, July 25, 2013 JCHC Conference Room

<u>Call to Order</u> - Chair Theresa Goodness called the meeting to order at Noon. Those in attendance were: Linda McMahen, Bruce Hamilton, Ron Ellington, Charlotte Holliman, Leslie McMahen, Bill Cummings, Paul Prosperie, Mike McGreevy, Peter Kaatrude and Guest (David Beard, Director of the Museum of the Gulf Coast, Port Arthur), and Guests Beth Black and Brenda Beadle.

<u>Introduction of Guest Speaker</u> – Chair Theresa Goodness introduced Brenda Beadle, Director of Capital Projects, City of Beaumont. Ms. Beadle spoke concerning the present state of the Tyrrell Park Community Building and plans the City of Beaumont have for the building. She reported the Mayor and City Council want to save the building but no funds were set aside in the 2013-2014 City Budget. There was time allowed for a question and answer period.

<u>Consideration of Minutes of Previous Meeting</u> - A motion was made by Paul Prosperie and seconded by Bill Cummings to accept the Minutes of the May, 2013 meeting as printed.

<u>Budget Report</u> - The Budget Report was given by Secretary/Treasurer Paul Prosperie. A motion was made and seconded to accept the report as printed. The motion was passed unanimously.

Chairman's Report - Theresa Goodness

- Theresa asked Peter Kaatrude to introduce his guest, David Beard. David is the new director of the Museum of the Gulf Coast. He is replacing Shannon Howard, former JCHC member, who has moved with her family to the Houston area. Theresa also introduced Beth Black who is interested in joining the Historical Commission at a later date. Ms. Black is presently in the process of moving.
- Theresa shared a new brochure that is being worked on updating information on the Historical Courthouse. This information will also be included on the JCHC website that is presently being updated and expanded.
- Certified Local Government Theresa shared that an application to the Texas Historical Commission from Jefferson County had been turned down. The County was applying for a \$10,000 grant (\$5,000 coming from THC / \$5,000 coming from the JCHC) to do a windshield survey of County areas that are not already classified as Certified Local Governments. The City of Beaumont and the City of Port Arthur are designated CLG.
- On March 25, 2013, Commissioners Court approved the use of public funds, county employees and equipment, and county inmate labor to clean-up and maintain Lincoln Cemetery also known as Broussard Cemetery, a historic cemetery located on Labelle Road in Precinct 4. The JCHC is waiting for a date to be set by Commissioner Alfred's office for the work to be started. Someone from the Jefferson County Historical Commission will need to be on site when the clean-up takes place. Volunteer assistance will be needed to locate and identify an unknown number of graves. Research has been ongoing and narrowing down the years of usage will help determine more about the cemetery.
