<u>Historical Markers</u> – Les McMahen reported the China POW historical marker will be installed on February 5<sup>th</sup>. The JCHC will make contact with Commissioner Alfred's office for a date to install the Moon Mullican historical marker in Magnolia Cemetery. Jimmy Sparks of Magnolia Cemetery was appreciative that the County would do the installation.
