

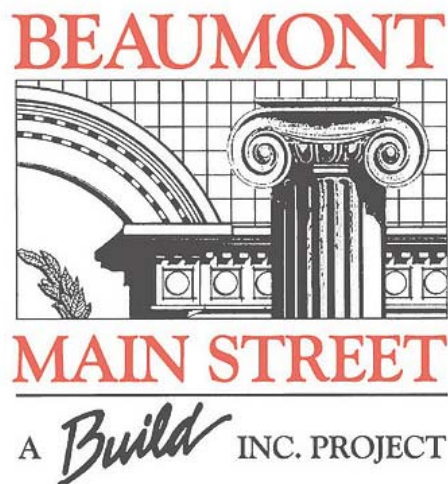
CHAIRMAN'S LETTER

JEFFERSON COUNTY FAST FACTS

\$220,503

Cost for county to purchase 155 voting machines from the Shoup Voting Machine Company of Philadelphia in September, 1949. This amount is equivalent to \$2.25 million in 2017 dollars.

\$2.00

Rate per day, per inmate, county charged U.S. Department of Justice to keep federal prisoners in county jail in 1960. This amount did not include hospital care.

\$28,260

Cost in 1990 to repair the front and back concrete steps to the Sub-Courthouse in Port Arthur.

TEXAS LEGISLATIVE NEWS

THC has alerted us to two identical, proposed bills that have been filed in the House (HB3265 by Representative Donna Howard) and Senate (SB 1630 by Senator Dawn Buckingham). These bills address several matters relating to the Health & Safety Code including:

- definitions for terms currently used in the law
- introduction of new definitions and a process for verification for filing record of unknown cemeteries
- landowner notification requirements for Notice of Existence of Cemetery filings
- concurrent reporting to landowners and THC for unverified cemeteries
- removal of the state registrar permit requirement for exhumations from certain types of cemeteries
- the inclusion of municipal or county cemeteries as options for reburial

HERITAGE HAPPY HOUR MAGNOLIA CEMETERY TOUR BY PAUL PROSPERIE



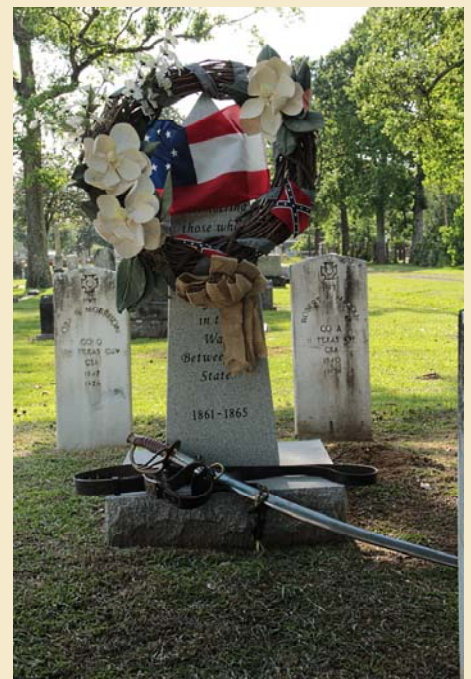

TEXAS HISTORICAL COMMISSION NEWS

On May 7, 2017, THC will offer free admission to 20 state historic sites. The state preserves and operates 21 historic sites, but this year the National Museum of the Pacific War will not be participating. In east Texas the sites are:

- Caddo Mounds in Alto
- Mission Dolores in San Augustine
- Starr Family Home in Marshall
- the Varner-Hogg Plantation in West Columbia
- Levi Jordan Plantation in Brazoria
- Sabine Pass Battleground in Jefferson County

THC will soon be releasing a five minute web movie about the Goliad Massacre. The film was shot using 360 ° video and tells the story of an infamous moment in the Texas Revolution when General Antonio López de Santa Anna ordered the execution on March 27, 1836, of 342 unarmed men under the command of Colonel James W. Fannin.

The men had surrendered after the Battle of Coleto in Goliad County and expected to be treated as prisoners of war, although Fannin had surrendered his men "subject to the disposition of the supreme government" of Mexico. A Mexican congressional decree of December 30, 1835, ordered captured armed rebels to be executed as pirates, and subsequently General Santa Anna ordered Fannin's entire command, along with William Ward and the Georgia Battalion, to be executed on Palm Sunday.

The bodies of the men were burned and left exposed to animals and the elements until June 3, 1836, when General Thomas Rusk gathered the remains and buried them with military honors. The site was unmarked until 1858 when a merchant, George von Dohlen, placed a pile of rocks at the believed location. In 1936 money was appropriated to build a pink granite monument which was dedicated in June of 1938.

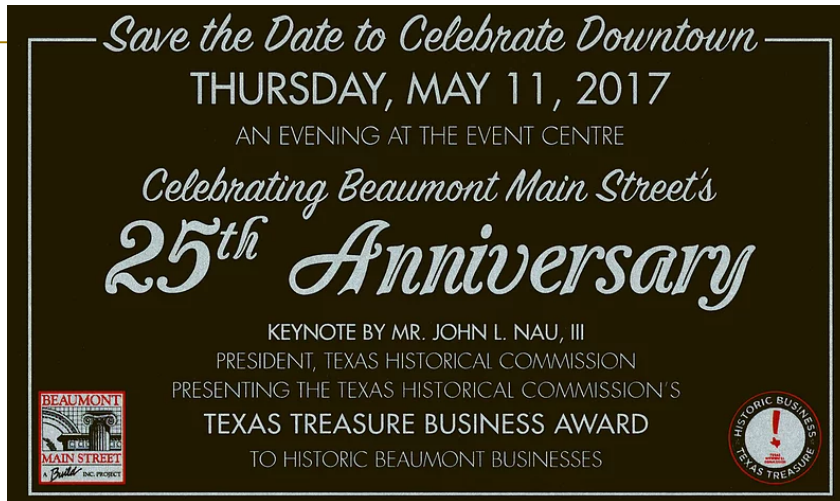

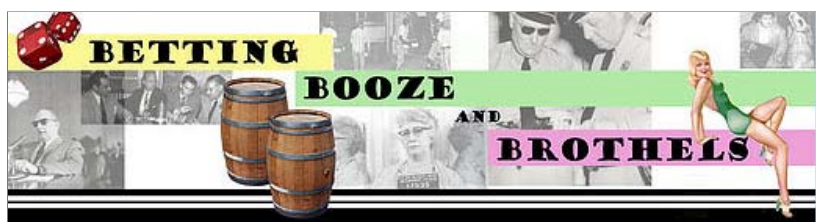
JCHC provided printed courthouse history brochures and other information for the tour participants.

PRESERVATION TEXAS

HB 3418 Threatens Historic Districts

Preservation Texas reports on HB 3418 which is a bill relating to municipal zoning affecting places or areas of historical, cultural, or architectural importance and significance. According to the [article](#) this bill would make it more difficult to enact preservation zoning ordinances by requiring a supermajority of three fourths of both the local planning or zoning board and the city council. It also requires an event associated with a site be “widely recognized” as historic before a landmark designation can be assigned.

The status of the bill as of May 1, 2017, is “Left Pending in Committee”.
