BEAUMONT HERITAGE SOCIETY HAPPY HOUR AT TYRRELL PARK STABLES

Beaumont Heritage Society held their bi-monthly Heritage Happy Hour at the Tyrrell Park Stables on February 28, 2019. The event was well attended by those who appreciate historic preservation efforts. The twelve stall stable building was constructed by the Civilian Conservation Corps (CCC) Camp 845 from 1935-1941 as a portion of the larger park project undertaken by the New Deal's Work Project Administration (WPA). The Camp built the golf course, nature trails, picnic tables, and other buildings.

Also constructed at Tyrrell Park by the CCC was the Tyrrell Park Community Building, currently the focus of a community-led drive for restoration. The City of Beaumont has encouragingly designated

\$2.1 million for a partial restoration of the building, and city officials have indicated the bid process may commence within sixty days.

The Tyrrell Park Coalition, the community activist group leading the push for restoration, has pushed for a full restoration of the building and for the roof to be completely replaced over the entire structure. The city's plans call for one wing of the building to be left without a roof. Although the rest of the building will undergo an extensive renovation including the addition of air conditioning, the group is concerned leaving the roof off a large part of the building will result in continued damage to the historic structure, and ultimately the loss of a significant portion.

Several Members of JCHC belong to the Tyrrell Park Coalition, and one member, Bruce A. Hamilton, is the Co-Chair, along with Laurie Leister. No doubt we will be hearing more soon on this important preservation project.

BEAUMONT MAIN STREET ANNUAL MEETING

Beaumont Main Street held its annual meeting on January 24, 2019, at Westminster Church located at 530 N. Main St., in downtown Beaumont. The Westminster congregation was formed May 8, 1921, by a union of the First and Central Presbyterian Churches. The First Presbyterian Church was organized in February of 1880. The church building now standing at the site was constructed in 1910 and was first opened for public worship on January 15, 1911. The congregation received an historical marker to commemorate the Centennial of the congregation in 1979. The current building has been purchased by another congregation which plans to restore the building and is already using it for services.

City Manager, Kyle Hayes, was the guest speaker, and his presentation was on the great strides the city and its private partners had made in investing in downtown Beaumont over the last twenty years. The city has invested in new paved sidewalks and lighting, funded a \$2.5 million expansion of Tyrrell Historical Library, built the Event Centre with a great lawn and lake, constructed Mountain Skate Park, and is in the process of constructing a Best Years Senior Center adjacent to these areas. Private businesses have invested millions more dollars in projects like the Rotary Club Centennial Park located near the Event Centre, the Edison Plaza revitalization by new owner, Albanese Cormier Holdings, the Port of Beaumont's \$16 million expansion, and more.

The Jefferson County Historical Commission (JCHC) was the recipient of a Ten-Year Member Award from Beaumont Main Street. The award was a picture of the organization's name on the marquee of the Jefferson Theater in downtown Beaumont. Chair, Sarah Bellian, and members, Theresa Goodness and Bruce A. Hamilton, accepted on behalf of the Commission.

The Jefferson County
Historical Commission is
proud to announce that a
collection of 22 postcards
of the 1893 and 1931
Jefferson County
Courthouse is on display
in the Mini Museum
located on the first floor of
the courthouse.

Fourteen of the cards are of the 1893 building and eight are of the current structure. The items on display are photographic

scans of the postcards, printed larger than actual size. Some of the cards have been posted while most have not. The ages of the postcards are from the early 1900s to the mid-1950s. A guide for aging postcards is included.

Postcards of the 1893 and 1931 Jefferson County Courthouse are from the collection of Jefferson County Historical Commission member Steven P. Lewis.

The second exhibit consists of 22 photographs of the exterior of the current courthouse showing architectural details of the art deco building. Most of the photos were taken with a telephoto lens to get a better view of features high above ground level, including eagles, ram's heads, cattle skulls, laughing faces, windows, and friezes. Two additional items are an 1899 photograph of the 1893 courthouse and a representation of the current courthouse as a line drawing.
