**Invitation for Bid**

Dear Bidders:

You are invited to submit bids in accordance with Invitation for Bid 08-024/DC, Low Pressure Sanitary Sewer System (Materials Only). All bids must be submitted with an original and three (3) copies to the Jefferson County Purchasing Agent, 1149 Pearl Street, 1<sup>st</sup> Floor, Beaumont, Texas 77701, no later than 2:00 PM, December 19, 2007. Bids will be opened at that time.

Bids are invited for several items and quantities of work as follows:

- 1,580 LF of 3" diameter PVC SDR 26 CL 160 Sanitary Sewer Force Main and Appurtenances
- 3,880 LF of 2" diameter PVC SDR 26 CL 160 Sanitary Sewer Force Main and Appurtenances

Specifications and plans are available for a non-refundable fee of \$50.00 from d.p. Consulting, 3727 Doctors Drive, Port Arthur, Texas 77642.

The County shall require the bidder to furnish a bid security in the amount of five percent (5%) of the total contract cost. The bid bond must be executed with a surety company authorized to do business in the State of Texas. Within ten (10) days after the date of the signing of a contract, the bidder shall furnish a performance bond to the County for the full amount of the contract, if the contract exceeds one hundred thousand dollars (\$100,000). Within ten (10) days after the date of the signing of a contract, the bidder shall furnish a payment bond to the County for the full amount of the contract, if the contract exceeds one hundred thousand dollars (\$100,000). If the contract is for one hundred thousand dollars (\$100,000) or less, the County may provide that no money be paid to the contractor until completion and acceptance of the work or the fulfillment of the purchase obligation to the County.

Attention is called to the fact that not less than the federally determined prevailing (Davis-Bacon and Related Acts) wage rate, as issued by the Office of Rural Community Affairs and contained in the contract documents, must be paid on this project. In addition, the successful bidder must ensure that employees and applicants for employment are not discriminated against because of race, color, religion, sex, age or national origin.
