**Invitation for Bid**

Dear Bidders:

You are invited to submit bids in accordance with the attached specifications packet, Invitation for Bid 09-011/JN, Bridge Replacements for Jefferson County: McDermand Rd, Thompson Rd, Green Pond Rd and South China Rd. All bids must be submitted with an original and three (3) copies to the Jefferson County Purchasing Agent, 1149 Pearl Street, 1<sup>st</sup> Floor, Beaumont, Texas 77701, no later than 11:00 AM, November 3, 2008. Bids will be opened at that time.

Specifications and plans are available for a non-refundable fee of \$25.00 from the Jefferson County Engineering Department, 1149 Pearl, 5<sup>th</sup> Floor, Beaumont, Texas, telephone 409-835-8584.

The County shall require the bidder to furnish a bid security in the amount of five percent (5%) of the total contract cost. The bid bond must be executed with a surety company authorized to do business in the State of Texas. Within ten (10) days after the date of the signing of a contract, the bidder shall furnish a performance bond to the County for the full amount of the contract, if the contract exceeds one hundred thousand dollars (\$100,000). Within ten (10) days after the date of the signing of a contract, the bidder shall furnish a payment bond to the County for the full amount of the contract, if the contract exceeds one hundred thousand dollars (\$100,000). If the contract is for one hundred thousand dollars (\$100,000) or less, the County may provide that no money be paid to the contractor until completion and acceptance of the work or the fulfillment of the purchase obligation to the County.
