Page 9 of the specifications –section 4, item 4.1 Contract Agreement –The contract tem is for one year from the date of the award. At the end of the first year there will be an option to renew the contract for an additional year. This option will continue at the end of each year for up to 4 renewals.

Page 10 of the specifications –section 4, item 4.4 Price Re-determination- At the time of each renewal the awarded vendor will have the option to submit a price change.

Page 15 Minimum Specifications- Instructions to Bidders- All of the locations of future projects are not known at the present time. Therefore prices should be bid by per cubic yard plus a delivery price for a single mile. The mileage for delivery will vary from project to project, but by establishing a price for a single mile the County will be able to apply the price regardless of the delivery site.
