You are invited to submit bids in accordance with specifications packet, Invitation for Bid (IFB 11-068/KJS), Sabine Pass Port Authority – Dredging (funded by Round 1 TDRA Grant Administered by The General Land Office of the State of Texas). All bids must be submitted with an original and three (3) copies to the Jefferson County Purchasing Agent, 1149 Pearl Street, 1<sup>st</sup> Floor, Beaumont, Texas 77701, no later than 11:00 AM, Tuesday, January 17, 2012. Bids will be publicly opened and read at that time.

**A Mandatory Pre-Bid Conference will be held on January 4, 2012 at 1:00 PM CST. The conference will be held at the Jefferson County Courthouse, 1149 Pearl Street, Beaumont, TX 77701, in the Comissioners' Courtroom on the fourth floor.**

The County shall require the bidder to furnish a bid security in the amount of five percent (5%) of the total contract cost. The bid bond must be executed with a surety company authorized to do business in the State of Texas. Within ten (10) days after the date of the signing of a contract, the bidder shall furnish a performance bond to the County for the full amount of the contract, if the contract exceeds one hundred thousand dollars (\$100,000). If the contract is for one hundred thousand dollars (\$100,000) or less, the County may provide that no money be paid to the contractor until completion and acceptance of the work or the fulfillment of the purchase obligation to the County.
