Item 4:

A typographical error has been identified in the schedule of values sheet of the Revised Bid Form. In lower right hand corner of the schedule under Additive Bid 2, the additive total line should read "Additive Bid 2 Total" rather than "Base Bid Total." The corrected page is attached. Pre-Bid Questions:

The following question was received prior to Bid Opening, and the answer is presented in blue italics, as follows:

13. Is it permissible to submit multiple bids, one for placement of dredged material in DMPA No. 5 and others for alternate placement locations/methods? If so, what is the procedure?

Yes. It is permissible to submit a bid for both the DMPA No. 5 placement and one or more alternative placement methods/locations. Bidders wishing to do so may return an additional schedule of values for each alternative as part of the Revised Bid Form. Up to two additional schedules will be accepted per Bidder.

Upon Bid Opening, each schedule will be tabulated with alternatives denoted as such.
