**Reason for Issuance of this addendum:**

■ **Revision to Minimum Specifications, page 13 as follows:** Prices may be adjusted only to reflect increases or decreases in rail rates, or as indicated on bid blank. The County shall require written verification on any increase in rail rates. Orders will be placed on an **as-needed basis** for the duration of the contract. Purchase orders will be released to the successful bidder(s) as required. ~~MINIMUM ORDERS ARE NOT ACCEPTABLE.~~ **Contractor may require minimum orders. However, Contractor MUST include Minimum Order Quantities on Bid Form.**

■ **Clarification:** **As per the Bid Form, bids must be by cubic yards. Bids received not using cubic yards for measurement will be considered non-responsive.**
