1. **Question:** Is Avis Budget Car Rental, LLC (hereafter "ABCR") currently in arrears to Jefferson County or Jack Brooks Regional Airport (hereafter BPT) for any debt of contract, default as surety, or otherwise upon any obligation to BPT? In other words, is ABCR current on all obligations to BPT and Jefferson County?

Answer: Yes, Avis has an account balance. No they are not current on all obligations to BPT and Jefferson County.

2. **Question:** Please confirm that the public bid opening will be on the same day and time as the deadline for bid submission, February 19, 2025 at 11 AM CT.

Answer: As per the Legal Notice, "Bids will be publicly opened and read aloud in the Jefferson County Engineering Department Conference Room (5th Floor, Historic Courthouse) 1149 Pearl Street, Beaumont, Texas 77701, at the time and date below. (11:00 AM CT, Wednesday, February 19, 2025) Bidders are invited to attend the sealed bid opening."

3. **Question:** Please confirm that the updated question answer date is Thursday February 6, 2025.

Answer: As per addendum 1, the deadline for asking questions was 5:00pm, CST, Thursday February 6, 2025.

4. **Question:** Page 42 of the IFB, section 4 – Disadvantaged Business Enterprises (DBE) Participation Goals, the actual goal is not provided. However, in the draft Concession Agreement, the proposed ACDBE goal is 0.16%, but it doesn't state whether that goal is based on gross revenues or the cost of goods and service expenses annually. Please provide the response as to what the goal is based on.

Answer: The goal is based on gross revenue.

5. **Question:** Will the Vendor Reference Form of the IFB (page 52) be required for the incumbent bidder?

Answer: Yes. All required forms should be completed.
