1. Question: Does food need to be prepared on site, or can it be prepared off site to be delivered, served, and cleaned up?

Answer: Food should be prepared onsite either in the café facilities located in the courthouse or via a portable kitchen/ food truck that you set up onsite.

2. Question: Will the county provide the dining facilities (serving tables, dining tables, tent or building, etc)?

Answer: All meal catering and serving supplies are the responsibility of vendor. A sit-down dining area is not required.

- 3. **Question:** Will the county provide all utilities, water, dumpsters, etc? Answer: Utilities are provided if meals are prepared in the café area. No utilities will be provided to portable kitchen/ food truck. All logistics and utilities for portable kitchens/food trucks will be the responsibility of the vendor.
- 4. Question: Appendix A seems to indicate that lunch and dinner include a sandwich / wrap AND a hot entree with sides for each person, please confirm Answer: Each person would have a choice of either a sandwich/wrap with sides OR a hot entrée plus sides.
