- c) Amend contract IFB 06-011/DD, Term Contract for Insecticides and Herbicides for Jefferson County Mosquito Control with Alenza, for the period of February 27, 2009 to February 26, 2010 for Item #4 Rodeo Herbicide from \$18.50 to \$35.50. The price increase is due to continued increased manufacturers costs.
