1 JUDGE DOLLINGER: We'll call the July meeting
2 of the Jefferson County Bail Bond Board to order.

3 First item of business is the review of minutes from
4 the last meeting. They were posted to the web a couple hours
5 ago. Tina has a copy here for anybody that's interested in
6 looking through them.

7 MS. LANDRY: They weren't actually posted yet
8 until they're approved.

9 JUDGE DOLLINGER: Oh, my bad.

10 MS. LANDRY: I will post them once everybody
11 approves them if you would like to look at them beforehand.

12 JUDGE DOLLINGER: Next is report from the
13 District Attorney's office regarding the status of collections.
14 Looks like it was a pretty good month. Props to the county
15 courts for all that money they brought in. The total is almost
16 \$67,000 which is a very high month.

17 Next is consideration/approval of applications
18 to become bondsmen, agents or renewals of the same. Do we have
19 any?

20 MS. GARCIA: No, sir.

21 JUDGE DOLLINGER: Okay. Complaints, I've
22 already been advised by the investigator, there are no
23 complaints.

24 Next is the treasurer's office report, which
25 has been disseminated to everyone on collateral balances. Are

1 there any discussions or comments, questions about the
2 treasurer's report. Hearing none --

3 JUDGE WEST: Judge, real quick before we go any
4 further, I think we need to vote. I make a motion that we
5 approve the minutes.

6 JUDGE DOLLINGER: Okay. I was going to wait
7 till the end so if anybody wanted to come look at them; but
8 that's great. No, that's a perfect way to do it.

9 We'll vote on these; and if anybody takes a
10 look at them and has a correction, all you need to do is let us
11 know and we'll go back at the next meeting and --

12 JUDGE WEST: Sorry. Never mind. I missed
13 that.

14 JUDGE DOLLINGER: No, no, no. That's okay.

15 JUDGE WEST: I take it back.

16 JUDGE DOLLINGER: No. Don't take it back. We
17 want to get them approved.

18 All in favor of approving the minutes as
19 they've been transcribed, signify by saying aye.

20 (RESPONSES MADE)

21 JUDGE DOLLINGER: All those opposed. Hearing
22 none, they're approved.

23 Any comments or questions on the treasurer's
24 report? Hearing none, the next is the report from the auditor's
25 office. Are there any noteworthy --

1 MS. BRODE: I'm way over here.

2 JUDGE DOLLINGER: Oh, I see. You're hiding.
3 Must be something bad. You're getting out of throwing range.

4 MS. BRODE: The only thing that I have to ask
5 is of the district clerk's office. Back in April, Judge Branick
6 specifically had a question about Paul Buchanan. The county
7 clerk and I have spoken to the district clerk's office, but she
8 has not reported any information back to me so that we can clear
9 him up. It's been a few months, and we need action.

10 MS. CORBELLO: Okay.

11 MS. BRODE: That's all.

12 JUDGE DOLLINGER: Okie dokie. Next is the
13 release of property to Al Reed. What is it that we're
14 releasing?

15 MS. LANDRY: We are releasing Lot 8 Glen Meadow
16 Townhomes and Unit 3 Building A Section 8 Park Meadow Townhomes.
17 I've verified with the county clerk and the district clerk's
18 office and they are in good standing once this is removed, which
19 I have already removed it and it still shows everything clear.
20 The release of lien is here and ready to sign once it's
21 approved.

22 JUDGE DOLLINGER: Okay. Any opposition to
23 releasing Mr. Reed's property to him?

24 Hearing none, that will be signed.

25 Next is cashier's check for Keith Day.

1 MS. LANDRY: Same thing on him. Everything is
2 clear. And I have the letter to have the treasurer release that
3 or bring it to commissioner's court and put it on the agenda
4 there and have it released.

5 JUDGE DOLLINGER: Any opposition to releasing
6 the cashier's check to Mr. Day pending the approval of the
7 commissioner's court? Hearing none, that, too, will be signed.

8 And last, the status of the Mormian (sp) lien
9 with the county.

10 MS. GARCIA: I did receive an e-mail back from
11 Judge Branick. He and I had been discussing this issue with
12 Clayton Mayfield. It seems our abstracts are going to survive
13 the sale because what they're going to sell the property for
14 won't even cover the taxes owed on this property. I do have an
15 e-mail from -- that was sent from Mr. Mayfield to Judge Branick
16 and Judge Branick forwarded it to me. So our abstracts will
17 still be out there for any other property that she may have with
18 the county but that we're unaware of.

19 JUDGE DOLLINGER: Okay.

20 MS. GARCIA: So this matter, I think, is a
21 closed matter.

22 JUDGE DOLLINGER: Okay. Any new business to
23 bring before the Bail Bond Board that was not put on the agenda?
24 Seeing no show of hands, any old business that needs to be
25 completed? Again, no show of hands.

1 JUDGE LIVELY: Motion to adjourn.

2 JUDGE DOLLINGER: Second that motion. All
3 those in favor.

5 JUDGE DOLLINGER: Okay.
