3 JUDGE DOLLINGER: The next is the auditor's
4 office. Did you get something from them, as well?

5 MS. GARCIA: No, sir, I did not.

6 JUDGE DOLLINGER: Okay. We don't have a rep from
7 the auditor's office, that I'm aware of, here today. So, we'll
8 bypass that.

9 Next is the release of property for Al Reed. And
10 what exactly is it that we're releasing?

11 MS. GARCIA: It's a piece of property he's
12 pledged as collateral. Tina has done -- ran the numbers; and
13 even removing it, he'll still have enough writing ability, which
14 won't affect anything. Tina has prepared the release and has
15 removed that information off the books pending your approval --

16 JUDGE DOLLINGER: Okay.

17 MS. GARCIA: -- your signing of the release.

18 JUDGE DOLLINGER: All right. Anybody have any
19 questions or comments about releasing that property back to
20 Mr. Reed?

21 MR. FUNCHESS: Do you know how much the value is?

22 JUDGE DOLLINGER: I do not.

23 MS. GARCIA: Stellina, do you remember the value
24 of the property?

25 MS. REED: Seems like it was, like, a hundred and

1 thirty, something like that.

2 MS. GARCIA: That sounds about right, when I
3 looked it up.

4 MS. REED: Somewhere around there.

5 MS. GARCIA: Tina and Mary were working on this.
6 I just kind of caught in on the tail end of it.

7 JUDGE DOLLINGER: She said roughly one thirty.

8 MR. FUNCHESS: Got it.

9 JUDGE DOLLINGER: Any other comments or questions
10 about Mr. Reed's request for release?

11 (NO RESPONSE.)

12 JUDGE DOLLINGER: All right. All those in --

13 MS. GOODNESS: Make a motion that we release the
14 property.

15 JUDGE DOLLINGER: Okay. I have a motion --

16 JUDGE WEST: Second the motion.

17 JUDGE DOLLINGER: -- to release and second.

18 All those in favor?

19 (RESPONSES GIVEN.)
