1 MR. FUNCHESS: We're going to call the July  
2 meeting for the Jefferson County Bail Bond Board together.

3 First order of business is to review the  
4 minutes from the last meeting. I have a set of them here if  
5 anybody needs to look at them. Everybody had a chance to review  
6 them? Any questions, comments, amendments?

7 JUDGE WEST: I move that we approve them.

8 MR. FUNCHESS: I've got a motion to approve  
9 them.

10 MR. KNAUTH: Second.

11 MR. FUNCHESS: Second. All in favor say aye.

12 (RESPONSES MADE)

13 MR. FUNCHESS: All opposed? None.

14 All right. Report from district attorney's  
15 office regarding status of collections on judgments. I think  
16 that's been passed out. Anybody have any questions or comments  
17 from the district attorney's office?

18 Hearing none, we'll move on to item number  
19 three which is consideration and approval of applications to  
20 become bondsmen or agents or renewals.

21 MS. GARCIA: There are none for this month.

22 MR. FUNCHESS: What about the man from Houston?

23 MS. GARCIA: He's going to be on next month's  
24 agenda?

25 MR. FUNCHESS: Okey doke. All right.

1                   Item number four is consider complaints against  
2 bondsmen.

3                   MS. GODINA: I don't have any.

4                   MR. FUNCHESS: Item number five is report from  
5 me on cash and CDs up for collateral. I've passed my report  
6 out. Does anybody have any questions or comments? All right.

7                   Hearing none, we'll move to item number six,  
8 which is a report from the auditor's office, Rhonda.

9                   MS. BRODE: I know this was going to be the  
10 fastest meeting in history, but I do have a question. I'm  
11 sorry. The attorneys, when the sheriff approves for the  
12 attorneys to go over their \$20,000, who is notified? How do we  
13 know that it was approved by the sheriff? Because right now, we  
14 have two; and I have no idea if the sheriff approved these.  
15 They are Cory Crenshaw and Mitchell Templeton.

16                  MS. LANDRY: That's really not a Bail Bond  
17 Board thing; so you would have to probably get with sheriff.

18                  MS. BRODE: I'm asking as the auditor's office.

19                  MS. LANDRY: Oh, okay. Yeah, you would  
20 probably have to get with the sheriff's office.

21                  MS. BRODE: You'll get with me?

22                  MS. VOORHIES: Yes.

23                  MR. FUNCHESS: Well, I thought usually if they  
24 went over the 20,000, they had to put up collateral.

25                  MR. GALMOR: Cory has money put up.

1 MS. BRODE: He does but it goes over what he  
2 has.

3 We had said that since the bail bond board  
4 isn't over the attorneys, the sheriff could say yes or no  
5 whether they wanted to allowed them to go over their 20. And  
6 when I got a couple of them that went over 20, I wasn't really  
7 sure what the procedure was going to be but I know we need  
8 something in-house so if we can just work something out, I would  
9 appreciate it.

10 MS. VOORHIES: All right.

11 MS. BRODE: Thank you, ma'am.

12 MS. VOORHIES: You're welcome.

13 MR. FUNCHESS: All right. Well, that concludes  
14 our agenda. Anybody have anything else they want to bring  
15 before the board without taking action?

16 I'll entertain a motion.

17 JUDGE WEST: I make a motion to adjourn.

18 MR. FUNCHESS: I've got a motion to adjourn.

19 Second?

20 MR. KNAUTH: Second.

21 MR. FUNCHESS: We are adjourned.
