1 JUDGE WEST: We will call the meeting to order.

2 The first item on the agenda is to review minutes
3 from last month's meeting. Those were emailed out, I think, to
4 everyone. And those are actually the meeting from June. And
5 then we will take up July and this meeting at the next meeting.

6 Did everyone have an opportunity to review those? I
7 need a -- and if you make a motion, if you're on Zoom, if when
8 you make a motion, if you would say your name please so that the
9 court reporter can get that.

10 MS. GOODNESS: Judge, this is Theresa. I make
11 a motion we approve those June minutes as written.

12 JUDGE WEST: Thanks, Theresa. Is there a
13 second?

14 MR. SMITH: Second.

15 JUDGE WEST: Jamie Smith seconded that. Any
16 other discussion from the month -- and it's actually from June?
17 All right. All those in favor, raise your hand, please.

18 (HANDS RAISED)

19 JUDGE WEST: All right. Any opposed?

20 All right. Oh, look. That was a good idea, what
21 Keith Day just did. He waved.

22 MR. DAY: Well, I can't -- I can't figure out
23 how to -- I'm on my cell phone so I can't figure out how to do
24 my video so --

25 JUDGE WEST: Oh, well, I thought you were just

1 being smart about it.

2 MR. DAY: I'm not smart. I was just pushing a
3 bunch of buttons.

4 JUDGE WEST: Okay. All right. That passes.
5 They're approved.

6 The second thing is district attorney's office
7 report on collections. Mr. Knauth is here. Any questions or
8 concerns about that report? Anything to add?

9 MR. KNAUTH: No, ma'am.

10 JUDGE WEST: All right. Thank you.

11 Next thing, consideration and approval of
12 applications to become bondsmen. Becky.

13 MS. BERTRAND: Judge, we have two.

14 JUDGE WEST: I'm going to ask you to do this,
15 just because everybody is on here. If you'll come step up to
16 the flat speaker that's right there will catch you. So if
17 you'll stand up here by me. Come on up and just use that as
18 your desk and that little speaker right there is on.

19 MS. BERTRAND: Okay. We have two that's going
20 to be renewed this month. The first one is going to be for
21 Derrick Dixon. He writes under the insurance company of
22 Lexington. This has been sent out to all voting members and
23 everything is in order.

24 JUDGE WEST: And that's Derrick Dixon?

25 MS. BERTRAND: Uh-huh.

1 JUDGE WEST: We will need a motion on that if
2 it's to be approved.

3 MR. SMITH: So moved for approval.

4 JUDGE WEST: Jamie Smith has made a motion.

5 MR. KNAUTH: Second.

6 MR. DAY: Keith Day, second.

7 JUDGE WEST: Pat, I think, beat you to it,
8 Keith. Pat Knauth, second.

9 Any other consideration or discussion on the
10 approval for the renewal on Derrick Dixon?

11 All those in favor, please raise your hand.

12 (HANDS RAISED)

13 JUDGE WEST: Any opposed, raise your hand. All
14 right. That passes.

15 MR. DAY: No.

16 JUDGE WEST: Who said no?

17 MR. DAY: No. I did. I was trying to take my
18 hand down. I'm sorry.

19 JUDGE WEST: The next?

20 MS. BERTRAND: The next one we have is Roshanda
21 Alexander. She is an employee of Allied Bail Bonds. Again,
22 this has been sent out to all the voting members and everything
23 is in order.

24 JUDGE WEST: All right.

25 MR. LIVELY: I make a motion to approve.

1 JUDGE WEST: Who said that?

2 MR. LIVELY: Judge Lively.

3 JUDGE WEST: Oh, thank you, Judge Lively. I've
4 got a motion.

5 MS. GOODNESS: This is Theresa. I second.

6 JUDGE WEST: All right. Motion and second.

7 Any other discussion with regard to the approval for the renewal
8 for Roshanda Alexander?

9 All those in fair, raise your hand, please.

10 (HANDS RAISED)

11 JUDGE WEST: Any opposed, please raise your
12 hand. All right. That passes.

13 And was that it, or was there a third?

14 MS. BERTRAND: That was it.

15 JUDGE WEST: Okay. Complaints against
16 bondsmen. Ms. Holmes.

17 Thanks, you guys. Have a good one.

18 MS. HOLMES: Judge, we don't have anything new.
19 We are still working on the same complaint and hope by next
20 month to be ready for a hearing, letters send out and
21 everything.

22 JUDGE WEST: All right. I don't know if you
23 heard Ms. Holmes. They're still working on and investigating
24 the complaint that she mentioned last month and anticipates the
25 letters being sent out and hopefully having any necessary

1 parties here to hear that complaint next month.

2 And that's it on that?

3 MS. HOLMES: Yes, ma'am.

4 JUDGE WEST: Report from treasurer.

5 MR. HALLMARK: Yes. I sent it out kind of
6 late, but I want to apologize for that. I had made copies for
7 everybody, but we were doing Zoom. So everything is fine and
8 everything is in order.

9 JUDGE WEST: All right. Anybody have any
10 questions of Mr. Hallmark? All right. Thank you, sir.

11 Let's see. Release of any property or CDs, do
12 we have anything?

13 MS. SEGURA: No, ma'am.

14 JUDGE WEST: We don't have that report.

15 And then report from the auditor's office.

16 MS. BRODE: Everything is in order. I've
17 talked to the county clerk, Becky, and she said that she is
18 working with MIS on getting the other counties cleared up --

19 JUDGE WEST: Any questions --

20 MS. BRODE: -- until we get that done.

21 JUDGE WEST: Okay. Any questions of Rhonda?
22 All right.

23 Well, that's all I have on the agenda. Is
24 there anybody that has anything they would like to bring up?
25 Any new business or old business that we haven't taken care of?

1 All right. This might be a record. All right.

2 Thank you. And is there a motion to adjourn from anyone?

3 MR. KNAUTH: Move to adjourn.

4 MR. SMITH: Second.

5 JUDGE WEST: We've got a motion and a second.

6 I assume everybody will put their hands up. Meeting is

7 adjourned. Everybody stay safe and healthy.
