19 MS. SEGURA: No.

20 JUDGE WEST: Okay. Auditor's office? Did we
21 get --

22 MS. SEGURA: No. I didn't hear from Rhonda. Did
23 you hear from her, Becky?

24 MS. BERTRAND: Huh-uh.

25 JUDGE WEST: Is that -- which report is this?

1 MS. BERTRAND: That's (indicating).

2 JUDGE WEST: That's yours?

3 MR. HALLMARK: My report.

4 MS. SEGURA: Hallmark's.

5 JUDGE WEST: And we didn't get a report from
6 them, from Becky --

7 JUDGE WOODS: Yeah, 'cause you do that spread
8 sheet.

9 JUDGE WEST: -- I mean from Rhonda?

12 MS. BERTRAND: I thought she may be out.

18 MR. DAY: I have a question for Becky. This may
19 or may not be a relevant issue, but on the new computer system

4 there could be six charges. So, it won't be a true reflection.

5 MR. DAY: Well, I'm talking more about the
6 bondsmen. So, if I posted a -- what's the statute of
7 limitations on a criminal case?

8 MR. GALMOR: Two or three or more.

9 JUDGE WOODS: Or seven.

11 MR. DAY: Yeah. So, if I posted a bond on an
12 accusation five years ago, you know --

13 MS. BERTRAND: Uh-huh.

14 MR. DAY: -- and that particular case may be out
15 of the statute of limitations -- then again, it may not -- how
16 are they going to decide? How does --

17 MS. BERTRAND: I'll make a note of that and see
18 if we have a cut-off time --

19 MR. DAY: Okay.

21 time period can't be included in that.

22 MR. DAY: Okay. All right.

23 JUDGE WEST: Another thing that came up is that
24 we realized that our minutes were not on the web site. So,
25 Kellie and Glenda noticed it and have been looking into it. And

1 what did you just find out?

2 MS. SEGURA: Mary Helm just called me; and she

7 MS. SEGURA: I will.

8 JUDGE WEST: There was a request sent or a -- we
9 were told, somebody was told that they were busy dealing with
10 Tyler Technologies and Odyssey and, so, they couldn't get that
11 done right and that's required for us by law. So, it's going to
12 get done right.

13 MS. SEGURA: But I'm sure if one of y'all called.

14 JUDGE WEST: Well, that's what we're going to get
15 to is I call them instead of -- if it's not up tomorrow, let me
16 know; and I'll call Monday myself.

17 MS. SEGURA: Okay.

18 JUDGE WEST: So, unfortunately we'll have to do
19 that.

20 MS. BERTRAND: I'm going up there shortly for a
21 meeting.

22 JUDGE WEST: Well, she just talked to her. So...

23 MS. SEGURA: Mary Helm just called --

24 JUDGE WEST: And I know they're very busy, but we
25 can't neglect what we have to do still while they're

1 transitioning.

2 MS. HOLMES: And busy's not going to go away
3 magically in October.

4 JUDGE WEST: No. So, we've got to get that
5 figured out.

6 Anything else? Anybody?

7 (NO RESPONSE.)

8 JUDGE WEST: All right. Is there a motion to
9 adjourn?
