1 JUDGE WOODS: Call the July 21st, 2022 Bail  
2 Bond meeting to order.

3 Number one on the agenda, review minutes from  
4 last month's meeting. I believe those have been posted. Is  
5 that correct?

6 MS. SEGURA: No, they haven't been posted.  
7 They haven't been posted yet.

8 JUDGE WOODS: Have not. Okay.

9 MS. SEGURA: But I will post them.

10 MS. BERTRAND: We have to approve them before  
11 they're posted.

12 JUDGE WOODS: I got you. Do I have a motion to  
13 approve last --

14 JUDGE JONES: So moved.

15 JUDGE WOODS: Second?

16 MR. HALLMARK: Second.

17 MR. LIVELY: Second.

18 JUDGE WOODS: All right. Approved and we will  
19 post.

20 Are there any other minutes out there that we  
21 need to --

22 MS. SEWELL: Yes, April. Those are mine.

23 JUDGE WOODS: Okay. All right. On number two,  
24 report from the district attorney's office. I believe that's  
25 been passed out. Any questions or comments regarding that

1 report?

2 Becky, was there something that you wanted --

3 MS. GARCIA: The next agenda.

4 JUDGE WOODS: On the next one. Okay. I  
5 thought you had something to say about the NISI's for some  
6 reason. No?

7 MS. BERTRAND: No. I mean, I e-mailed it out  
8 to everyone.

9 JUDGE WOODS: Okay. But no --

10 MS. BERTRAND: I just e-mailed it out.

11 JUDGE WOODS: I thought you said there was a  
12 question.

13 MS. BERTRAND: I'm just the middle man.

14 JUDGE WOODS: All right. Got you. All right.  
15 Number three, consider applications for bondsmen and agents. Do  
16 we have any?

17 MS. SEGURA: Two.

18 JUDGE WOODS: Two.

19 MS. BERTRAND: We got two. The first one is for  
20 Derrick Haynes. He is renewing his application. He's been in  
21 business with us for several years now. I did e-mail it out to  
22 all the members excluding the exhibits because it was just too  
23 large to e-mail. But everything is in order.

24 JUDGE WOODS: Okay. Do I have a motion to  
25 approve?

1 JUDGE JONES: So moved.

2 CHIEF SHAUBERGER: Second.

3 MR. HALLMARK: Second.

4 JUDGE WOODS: Then his application will be  
5 approved.

6 And then second?

7 MS. BERTRAND: The next one we have is a  
8 original application for Julie Christian. She's going to be  
9 working for Allied Bail Bonds as a bail bond representative.  
10 It's also been e-mailed out to everyone, and everything is in  
11 order.

12 JUDGE WOODS: Do I have a motion to approve  
13 hers?

14 JUDGE JONES: So moved.

15 MR. LIVELY: Second.

16 MR. HALLMARK: Second.

17 JUDGE WOODS: Motion, second. That will be  
18 approved. I guess, I should say -- let me back up.

19 On both applications I'll make a -- all in  
20 favor say aye.

21 (RESPONSES MADE)

22 JUDGE WOODS: Any opposed? Hearing none, those  
23 will be approved. Okay. Any more?

24 MS. BERTRAND: No, sir.

25 JUDGE WOODS: Okay. And then number five on

1 the agenda, report from treasurer's office on cash and CDs and  
2 collateral.

3 MR. HALLMARK: Nothing to report.

4 JUDGE WOODS: Nothing to report.

5 Number six, release of any properties, CDs,  
6 cash or cashier's checks.

7 MS. SEGURA: Yes. Eric James and he's in  
8 compliance.

9 JUDGE WOODS: He's in compliance?

10 MS. SEGURA: Yes.

11 JUDGE WOODS: All right. Then do we have a  
12 motion to release this property?

13 MS. BRODE: I'm sorry. Eric James?

14 MS. SEGURA: Yes.

15 MS. BRODE: Are we releasing all of his  
16 property?

17 MS. BERTRAND: No, no, no.

18 MS. SEGURA: No.

19 MS. BERTRAND: He's got two of them pledged.  
20 We are just releasing one of them. The remaining property is  
21 enough to carry what he owes.

22 MS. BRODE: What are we releasing?

23 JUDGE WOODS: You want to look at this?

24 MS. BRODE: Thank you.

25 JUDGE WOODS: Everything in order? Okay. So

1     then do I have a motion to release the property for -- what is  
2     his name?

3                     MS. SEGURA:   Eric James.

4                     MR. HALLMARK:   I make a motion.

5                     MR. LIVELY:    Second.

6                     JUDGE WOODS:   All in favor say aye.

7                     (RESPONSES MADE)

8                     JUDGE WOODS:   Any opposed?   Hearing none, that  
9     will pass.

10                    Anything else on releases?

11                    MS. SEGURA:   No.

12                    JUDGE WOODS:   Then lastly, report from  
13   auditor's office.

14                    MS. BRODE:    They were distributed, and I have  
15   no comments.

16                    JUDGE WOODS:   Any other new business?

17                    MR. DAY:    I have -- Becky, I guess --

18                    MS. BERTRAND:   Judge, you skipped number four,  
19   though.

20                    MS. SEGURA:   Complaints, number four.

21                    JUDGE WOODS:   Oh, I sure did.   I need glasses.  
22   Going back -- I'm sorry -- I skipped over an agenda item.

23                    Are there any complaints against of any of the  
24   bondsmen?

25                    MS. HOLMES:   No, sir.

1 JUDGE WOODS: No complaints. Perfect.  
2 Going back, any more new business?  
3 Any old business we need to cover? Okay. All  
4 right.

5 Do we have a motion to adjourn?

6 CHIEF SHAUBERGER: I make a motion.

7 JUDGE JONES: Second.

8 JUDGE WOODS: All approved. We gone.
