1 JUDGE WOODS: It's 12:30. Call the August 15th,
2 2022 bail bond meeting to order.

18 Report from the DA's office, I believe
19 that's -- do I have a report from the DA's office?

20 MS. SEGURA: Well, no.

24 MS. SEGURA: No, they didn't e-mail it. Is

4 MS. SEGURA: You saw it?

5 CHIEF SHAUBERGER: I think I did.

6 MS. SEGURA: I didn't see that. I saw what
7 Becky sent, but I didn't see anything from the auditor's office.

8 JUDGE WOODS: Let's just assume there is no
9 issues. Everything is good. We are going to assume everything
10 is good with the auditor's office.

11 MS. SEGURA: Yeah, and she can present it next
12 month.

14 new business to cover?

15 MR. REED: Under the old business, Mr. Roebuck
16 was supposed to give us a report. Is that done yet?

18 MR. ROEBUCK: Yeah, that's what it was. Yeah.

19 MR. REED: And, you know, they -- they didn't

22 MR. ROEBUCK: Committed a crime.

23 MR. REED: So that person that didn't report
24 it, the GPS, you know, could have some liability.

1 nobody -- is that what you're saying, so he had a GPS monitor
2 but committed an offense while he was wearing it but nobody knew
3 he had a GPS monitor?

4 MR. REED: He cut it off.

5 MR. ROEBUCK: He cut it off and it wasn't
6 reported.

7 MR. LIVELY: Oops.

9 woman that's been charged with all the offenses, stealing from
