1 JUDGE WEST: Good afternoon, everyone. We will  
2 start the meeting.

3 So first is to review minutes from last month's  
4 meeting. Those should have been, I think, emailed a few days  
5 ago. Does anyone have any questions or concerns? We need a  
6 motion and a second to approve those if not.

7 JUDGE WOODS: I make a motion to approve the  
8 minutes.

9 JUDGE WEST: I've got a motion.

10 MR. GALMOR: I'll second.

11 JUDGE WEST: The second was from Mr. Galmor.  
12 Any other questions or concerns about the minutes? All those in  
13 favor say aye. How about all those in favor raise your hands  
14 because you're all muted. Raise them high so I can see.

15 Any opposed? How about you raise your hand if  
16 you're opposed. All right. That passes.

17 Number two, let's see, report from the district  
18 attorney's office. Mr. Knauth is not able to make it. You  
19 should all have that report emailed to you as well. I think  
20 that's just for information, though. We don't vote on that.  
21 Anybody have any issues on that report?

22 Oh, shoot. Hang on, y'all. I didn't go live.  
23 Hold on. Okay. Sorry about that.

24 Next thing is consideration and approval of  
25 applications to become bondsmen or renewals. Are there any?

1 MS. GODINA: No.

2 JUDGE WEST: There aren't any.

3 Complaints against bondsmen, do we have any?

4 MS. GODINA: Not any.

5 JUDGE WEST: The report from the treasurer on  
6 cash and CDs. Everybody should have a copy of that.

7 MR. HALLMARK: Nothing to report.

8 JUDGE WEST: Thank you, Mr. Hallmark.

9 Any release of property, CDs, cash or cashier's  
10 checks, anything like that?

11 MS. SEGURA: No.

12 JUDGE WEST: No. Then we have the report from  
13 the auditor's office.

14 Oh, look, Mr. Roebuck just decided to -- we'll  
15 let him in. All right.

16 Anything from the auditor, Ms. Brode?

17 MS. BRODE: No, ma'am. If anyone at the jail  
18 could let Shauburger know that the one attorney that I'm keeping  
19 an eye on for him has not changed, he'll know it. I appreciate  
20 it.

21 JUDGE WEST: All right. That's it on the  
22 agenda.

23 I want to -- there was something that came up  
24 and Keith Day's not here so we'll probably have to kind of wait  
25 and talk to him about it. There was an affidavit of surety to

1     surrender that was presented to a JP because it wasn't -- the  
2     case had not been indicted yet so it wasn't assigned to a court  
3     and that JP granted it and signed off on it but the issue then  
4     becomes a couple of things; one, Mary and Glenda need to know so  
5     they can put that information in and we're not real sure if a  
6     warrant was issued or how a warrant would be issued because the  
7     JPs don't do that. So I think if we have the -- anybody, maybe  
8     we need no just get word out to the bondsmen, if they need to do  
9     that, if the case hasn't been indicted yet, they need to kind of  
10    take an extra step and get that information to one of the  
11    district courts or at least to Mary or Glenda so they can put  
12    all of that in the computer the way it needs to and the warrant  
13    goes out because right now we have a copy -- we have a signed  
14    affidavit but I don't know what else has happened on it.

15                 MS. GODINA: Well, on this particular case it  
16    was okay because the person got taken back into custody the next  
17    day. But in the future if they're not in custody, then they'll  
18    be out on the street and they won't have a warrant either until  
19    the case becomes indicted.

20                 JUDGE WEST: Right. So at least there needs to  
21    be an at large without proper bond or something where we can get  
22    them in custody.

23                 MS. GODINA: Right.

24                 JUDGE WEST: Glenda, if you make a note to put  
25    that on the next agenda and maybe when Keith is here, we can

1 talk to him and he can get word out to all the bondsmen to make  
2 sure that if they have those, that they need to take an extra  
3 step to get us a copy of it.

4 The only other thing I wanted to bring up,  
5 obviously as long as we have to, we'll keep doing meetings this  
6 way. For those who have to do reports and get us reports, if  
7 y'all can please get your reports to Glenda the week before the  
8 meeting so she can get them out to all of us. If you can't get  
9 them to her, by maybe that Friday before and you're sending them  
10 at the last minute, then we're going to ask if you would please  
11 just e-mail everybody in the group because if she's here or not  
12 here, she's covering lots of different jobs so if we can just  
13 try to get those reports the week before to Glenda and she'll  
14 get them to everyone. If not, then I'm going to ask everyone  
15 who does a report to send it to the whole group themselves.

16 MS. BRODE: Judge, was it okay what I did  
17 yesterday because my report has to be last minute because of the  
18 balances? Did everyone get theirs?

19 JUDGE WEST: I think so. I did. Yeah, that's  
20 different because, yeah, obviously yours -- and if there is  
21 anything in anyone's that is last minute, we understand that but  
22 as soon as we can, that's great. We appreciate it.

23 Anything else that anybody else wants to bring  
24 up? No. Anybody want to --

25 JUDGE WOODS: Make a motion to adjourn.

1 JUDGE WEST: Judge Woods made a motion to  
2 adjourn.

3 MR. HALLMARK: I'll second.

4 JUDGE WEST: I think that was Mr. Hallmark. I  
5 think there were two or three actually might have said it at the  
6 same time. Everybody is ready to go.

7 All those in a favor, raise your hand.

8 Any opposed? All right. Thank y'all. Have a  
9 great day.
