1 JUDGE WEST: I'm going to call the meeting to
2 order. Do we have enough people?

3 JUDGE JONES: I'm here.

4 MS. BERTRAND: Yes, we got a quorum.

5 JUDGE WEST: All right. The first item on the
6 agenda, review minutes from last month's meeting. Were those
7 sent out?

8 MS. SEGURA: Last month, Ada is working in
9 County Court 2 and she didn't have time to complete them but she
10 said she will have them next month.

11 JUDGE WEST: All right. We will take care of
12 that next time. If you will make sure to put that date again on
13 next month so that we know we're a month behind on that.

14 Report from district attorney's office.

15 MS. BERTRAND: That one isn't being sent out
16 right now. The district clerk couldn't get their reports to
17 run.

18 JUDGE WEST: Okay. Any approval -- any
19 applications for renewals or new --

20 MS. BERTRAND: No, ma'am.

21 JUDGE WEST: Any complaints?

22 MS. HOLMES: No, ma'am.

23 JUDGE WEST: Report from treasurer, anything to
24 report?

25 MR. FUNCHES: I've handed it out.

1 JUDGE WEST: Anybody have questions on the
2 report tha you've gotten from the treasurer?

3 Okay. Any release requests?

4 MS. SEGURA: I'm sorry. Yes. And he'll be in
5 good standing.

6 JUDGE WEST: All right. We have a request from
7 Keith Day to release cashier's checks totaling 145,000;
8 cashier's checks number 268779, 269316, 275380, 275732, and
9 275966 and he'll still be in good standing if we do this. Does
10 anyone want to make a motion on that?

11 JUDGE WOODS: I make a motion to approve.

12 MR. GALMOR: I second.

13 JUDGE WEST: I've got a motion by Judge Woods,
14 second by Mr. Galmor. Any discussion on that?

15 All in favor.

17 JUDGE WEST: Any opposed? All right. That's
18 done.

19 Report from the auditor's office, do we have
20 the same issue with that?

21 MS. BERTRAND: Same issue with that.

22 JUDGE WEST: All right. That's it.

23 MS. BERTRAND: Mary was going to come down and
24 speak to everyone so I guess I'm just going to kind of fill in
25 for her. Literally, we just were able to run that report

1 showing liability that you saw for Keith. We just did that so
2 that's something that we are finalizing to get y'all's e-mails,
3 y'all's reports every morning. It's like -- it's -- we're so
4 close on it. It's almost there. Because of where the data
5 fell, we're having to shift that data to other columns where the
6 reports are going pick up that data. They were just not in the
7 right place. As soon as we get that done, we should be able to
8 get y'all's information out to you daily.

9 CHIEF SHAUBERGER: We still haven't made it
10 through the backlog on the accusations so ...

11 MS. BERTRAND: No. But that will increasingly
12 show as they get their stuff.

13 CHIEF SHAUBERGER: Hopefully it will start by
14 next week.

15 MS. BERTRAND: So I think that's pretty much
16 what Mary was going to tell everyone is that we are -- she
17 apologizes but, you know, we've just been under the gun in so
18 many different areas but it is a top priority for us. We are so
19 close on the portal. The portal is the other thing that we
20 --really has been hanging us up in our departments, trying to
21 get y'all logged in and to see what y'all need to see but we,
22 again, we haven't forgotten about y'all.

23 JUDGE WEST: And if y'all have frustrations
24 about it, just imagine the frustrations that are going on around
25 here. Nothing has gone smoothly. There is -- we still are

1 having a lot, a lot of issues, even with just the logging on to
2 their computers, our clerks. So it's really, really not been a
3 good transition at all.

4 MS. BERTRAND: No.

5 JUDGE WEST: So we're working on it and there
6 is lots of frustration so please be patient with everybody on
7 all of that.

8 MS. BERTRAND: But, again, if y'all have any
9 questions or anything, send me an email. I'll try to get on it.
10 We certainly want to help y'all because it's a two-way street
11 so --

12 JUDGE WEST: For sure.

13 MS. BERTRAND: -- I think that was pretty much
14 it.

15 JUDGE WEST: Anything else? Any other
16 business?

17 JUDGE JONES: I move that we adjourn.

18 JUDGE WOODS: I second that.

19 JUDGE WEST: Done. We're adjourned.
