6 to have that meeting; and I will bring it up at that meeting and
7 let y'all know what they say.

9 Ronnie passed away. I had asked -- had Kellie ask Becky if we
10 had any funds or anything that we could send and we don't. If
11 anybody wants to get together and send something, we can talk
12 about that for his services. I don't know anything about it.

13 MR. DAY: They're not having services.

14 JUDGE WEST: They're not. Okay. Then we won't worry
15 about that.

16 MR. DAY: They're going to take a boat out in the
17 Sabine.

18 JUDGE WEST: Any other business that's not on the
19 agenda that anybody needs to bring up?
