# Call to Order / Greetings - 1st Chair Les McMahen

#### **Annual Meeting - Election of Officers**

This is the year JCHC members will have an opportunity to nominate people for our Executive Board. At this meeting, nominations for Chair, First Vice-Chair, and Second Vice-Chair may be made. (Please note the position of Secretary / Treasurer is not a position voted on by JCHC membership. As an employee of the County and approved by Commissioners Court, this person is the sole individual responsible for

handling all financial matters of the JCHC, with consideration of suggestions made by the JCHC.)

Nominations shall be made and presented in writing to the general membership. Nominations may also be accepted from the floor from any voting member with the consent of the nominee. There must be a two week period between nomination and voting. Due to time requirement (and Chair on vacation), a Special Meeting is called for Friday, December 9, 2016 for voting.

Election shall be by written ballot unless there is one candidate and a motion is made to elect by acclamation. A simple majority vote of those present qualified to vote, and voting, shall constitute election. Proxy or absentee voting will not be allowed in officer elections.

Nominations were made by members in attendance to continue to retain Theresa Goodness as Chair, Les McMahen as 1<sup>st</sup> Chair and Paul Prosperie as 2<sup>nd</sup> Chair. Voting will take place December 9, 2016.

# Recommendation of Programs and Activities for the Ensuing Year

Sarah Bellian of the Museum of the Gulf Coast reminded everyone of the exhibit "Betting, Booze, and Brothels" scheduled for May 2017. Items are still needed for the exhibit.
