JEFFERSON COUNTY COMMISSIONER'S COURTROOM RESTORATION

In the January, 2016, edition of the JCHC Journal appeared an article describing the extensive termite damage in the Jefferson County Commissioner's Courtroom and other District Courtrooms. The Commissioner's Court authorization of \$437,000 to restore this court and certain District Courtrooms has yielded beautiful results. For the first time since restoration began early this year, Commissioner's Court was held Monday, June 27, 2016, in the fully restored courtroom instead of in the Jury Impanelling Room. County staff and members of the public remarked on the quality of the restoration, the harmonious view of the bench where members of the Court sit, and the beauty of the polished wood.

The architectural firm Shepley Bulfinch and carpenter David Weston are to be congratulated on such a fine job, and the Court commended for not only recognizing the value of preserving our priceless history, but also taking the concrete steps necessary to do so. Job well done!

HAMSHIRE-FANNETT AREA

MOREY WAS AN AREA BETWEEN FANNETT AND HAMSHIRE WHERE THE LITTLE SETTLEMENT OF ODELIA WAS LOCATED. UNTIL RECENTLY, THIS RAILROAD MARKER WAS VISIBLE FROM HWY, 124 AT THE INTERSECTION OF CRAIGEN ROAD. IT IS NO LONGER THERE, BECAUSE THE RAILROAD TRACK WAS REMOVED. ODELIA WAS A SAWMILL TOWN WHERE THE HARGRAVES FAMILY GREW UP. IT WAS LOCATED BEHIND THE RAILROAD TRACKS. THE COMMUNITY OF ODELIA WAS IN EXISTENCE BEFORE 1903 WHEN THE SAWMILL WAS STARTED BY EDGAR CARUTHERS. THE SAWMILL WAS THE BASIS FOR A TOWN BEING BUILT, AND THUS THE NEED FOR A SCHOOL, WHICH WAS NAMED ODELIA, AFTER THE TOWN. IT WAS A ONE-ROOM BARN-LIKE STRUCTURE MADE FROM THE PLANKS OF THE SAWMILL THE SAWMILL BURNED IN 1912, AND THE SCHOOL DID NOT SURVIVE LONG ENOUGH TO FOLLOW THE PATTERN OF THE OTHER SMALL SCHOOLS IN THE AREA.....CONSOLIDATION.

The following is an excerpt from the minutes taken by Sarah Bellian of our CLG meeting held on June 7, 2016, at the J.P. Precinct 4 Building in Fannett.

"We had some trouble getting the word out for this meeting. At least two people who attended the China meeting and expressed interest in attending this meeting did not attend. JCHC members in attendance — Linda McMahan, Theresa Goodness, Bruce Hamilton, and Sarah Bellian.

Also in attendance –

Fred Renkema ... has a collection on the area including very old abstracts, specifically related to Dutch settlement and early farming Renkema is the grandson of early settler Nicholas DeYoung who came to Chicago in 1897 with some of his siblings from the Netherlands. bought 24 acres from Coke along with 103 Dutch families. When the 1915 flood hit with a 17 foot storm surge the Winnie and Hamshire Fannett areas were completely submerged. Most of the families abandoned their vegetable farms in the area, but the DeYoungs returned and became dairy farmers. DeYoung was called by W.T. Block "father of the Texas fig industry" and there was fig processing at several sites locally. Mr. Renkema is also involved in the 100th anniversary of the Lions Clubs of Southeast Texas (Beaumont and Port Arthur) which is upcoming and possibly an organization to be commemorated with a marker."

BEAUMONT HERITAGE SOCIETY HERITAGE HAPPY HOUR TOUR OF MILDRED BUILDING

Beaumont Heritage Society hosted their bi-monthly Heritage Happy Hour at the Mildred Building on Thursday, June 16, 2016. Many area residents enjoyed the opportunity to tour this iconic Mediterranean Revival style apartment, commercial and garage center built by Miles Frank Yount in 1929-1930 for \$700,000 and named for his daughter, Mildred Yount. Mr. Yount was known as the godfather of Beaumont due to his generosity in meeting the City's payroll one Christmas during the depression. He died suddenly at the age of 53 on November 13, 1933, on the eighth anniversary of Spindletop's second discovery.
