Announcements of 'READY" are required on all designated "TRY OR DISMISS" cases. PLAINTIFF'S FAILURE TO ANNOUNCE "READY" FOR TRIAL BY DOCKET CALL DATE ON A CASE THAT IS DESIGNATED "TRY OR DISMISS" WILL RESULT IN THAT CASE BEING DISMISSED FOR WANT OF PROSECUTION. If it is not, in the opinion of any party, ready for trial, a Motion for Continuance must be filed and a hearing must be set with the Court before the docket call date.

ANNOUNCEMENTS:

Please note: *There court will no longer hold in-person docket call announcement.* Your announcement may be given to the Court at any time after you receive this docket. You do not have to wait until docket call day to give your announcements but they must be made on or before docket call day. *When making your announcement, please advise the court the length of time the case will take to try.* All announcements, including announcements of "settled", must be made by letter efiled with the Court. No announcement will be received by telephone or email.

PREFERENTIAL SETTINGS:

IF THE CASE HAS BEEN PREFERENTIALLY SET THE CASE IS ASSUMED READY AND NO CONTINUANCE SHALL BE GRANTED.

Numbering of Cases: Cases will be numbered the TUESDAY FOLLOWING docket call and posted to the Court's website to reflect the case's placement on the trial docket.

CONTINUANCES:

A case set on the docket for the first time may pass the setting by agreement of the parties. Prior to the removal of the case from the docket, the parties <u>shall</u> file an amended docket control order prior to docket call. Absent the filing of an amended docket control order, the case will be called to trial.

***PLEASE NOTE: NO CONTINUANCES WILL BE GRANTED AFTER THE DOCKET HAS BEEN NUMBERED AND CASES SET FOR TRIAL WITHOUT A HEARING.

RESETTINGS BY THE COURT:

A case on the trial docket is considered "Trial Ready", and may be automatically set on subsequent dockets. NO request or announcements will be necessary to effectuate the resetting of a case, although a party may request a setting.

IF YOU REQUIRE MORE THAN A 40 PERSON JURY PANEL, YOU MUST NOTIFY THE COURT IMMEDIATELY AFTER RECEIVING THIS DOCKET.

NOTE WELL: In addition to the cases listed herein, this month's docket may also include other cases which were added after the docket was published, such as cases carried over, cases re-set or continued from prior months.
